

## REGULAR MONTHLY BOARD MEETING NOVEMBER 6TH 2025

The Town of Mayfield held the Regular Monthly Meeting on November 6<sup>th</sup>, 2025, at 6:00 PM at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 12117. The meeting was opened by Supervisor Brandon Lehr with the Pledge of Allegiance.

PUBLIC COMMENT: Bob Murphy again complained that the end of VanDenburgh Point Rd is not paved yet and there is pot holes.

### DEPARTMENT REPORTS:

Acting Highway Superintendent Christopher Warner submitted his report stating that the Highway department has been cleaning brush from town roads. Fridays wind storm resulted in trees down and staff called in to do clean up. Trucks have all had oil changes and grizzlies put on. Truck inspections are due, and we are working on them. A town provided cell phone would be ideal to have to give to the public. A dedicated Highway Superintendent phone could also be given to the Deputy Highway Superintendent when the Superintendent is absent. Would like to start interviewing for help and be able to hire as soon as possible.

CEO/BI Norman Barbosa submitted his report stating he issued 10 permits, 21 inspections, 1 complaint, 3 foil requests, 5 closed permits, and 24 in office visits. Codes Officer Edwards has completed his official certification training. He also brought 3 more violations into compliance. Still working with CloudPermit. Both Codes officers will be attending training next year. ZBA will meet December 3<sup>rd</sup> for a public hearing on a setback variance and a new variance request for a subdivision on Kunkel Point Rd. The Planning Board will meet on November 19 for a self storage on Woods Hollow Rd.

Assessor Connie Henry submitted her report stating that she attended the NYSSA conference in October and won a free scholarship for next years conference. Approximately 100 Senior Aged Exemption Renewals for 2026 have been mailed out and some are coming back already. NYS has taken over all STAR exemptions including Enhanced STAR. I have very little confidence that this will be a smooth transition and I am expecting angry homeowners. Certificate of Continued Occupancy or CCO information was supplied to the board members. It would have to be modeled to fit our needs if we decide it will be something that we would like to enforce.

## Dog Control – no report submitted

Supervisor Brandon Lehr gave his report stating that there is no Bridge NY grant available this year and will reach out to the engineering form for other options. Also met with Beach Director Parris Beach and HRBRRD regarding grants available for beach improvements, such as a pavilion, permanent restrooms, electric. Also discussed the Beach vandalism.

Fire district contracts also discussed. Supervisor attended a zoom meeting with CDPHP to discuss HRA/HAS card options. Sales tax has dropped a little since this quarter last year.

No public comments at this time. Councilman Desiderio stated he was comfortable with the Budget as written.

## NEW BUSINESS

Crowd Strike has been installed on the Clerk Computer as a test and there have been no problems.

Councilman Desiderio stated to Bob Murphy that the State Law has been passed regarding short term rentals and the County would be tracking them. Paving was discussed again.
