# REGULAR MONTHLY BOARD MEETING AUGUST 12<sup>TH</sup> 2025

The Town of Mayfield held the Regular Monthly Meeting on August 12<sup>th</sup>, 2025, at 6:00 PM at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 12117. The meeting was opened by Supervisor Brandon Lehr with the Pledge of Allegiance.

PUBLIC COMMENT: Bob Murphy complained about the end of Vandenburgh Point Rd not being paved again. An appointment with the Supervisor and Acting Highway Superintendent is set for next week to look at the road.

#### **DEPARTMENT REPORTS:**

Acting Highway Superintendent Christoper Warner submitted his report stating that the Highway department has been out cutting brush, patching and filling in potholes. All the roads that we can do this year have been blacktopped. The County came and helped do the shoulders. Fixing and putting up road signs, mowing is done for the second time. Fixing driveways where the paving company left a big drop off. The FCC license for truck radios has been renewed. Two trucks are down, one with broken springs, one with no power. We have also helped the county draw rubble for shoulders and helped Northville and Bleeker draw blacktop.

Beach Director Parris Beach stated that the beach will close on August 24th at 1:30.

CEO/BI Norman Barbosa submitted his report stating that 9 permits were issued, 24 inspections were done, there were 5 complaints, 4 foil requests, 2 permits were closed and there were 20 office visits. The Cloud Permit system is working very well. The planning board is meeting on the 20<sup>th</sup> to resume the public hearing for Sunset Bay. An upcoming planning board meeting will evaluate the application for Self storage at 111 Woods Hollow Rd. Code officer David Edwards is completing training. Shout out to Assessor Connie Henry for her work in getting Cloud Permit off the ground and working!

Supervisor Brandon Lehr gave his report stating that sales tax is up for this quarter from last year. Lengthy discussion about the gates on Warner Hill Rd. Gates are placed on Warner Hill off of County Highway 123 and Off of Tolmantown Rd.

Dog Control Officer Karen Wilson submitted her report for May and June stating there were a total of 5 dog complaints, 3 miscellaneous complaints, 2 dog bites and no dogs taken to the shelter.
