Town Board Special Meeting February 28, 2017

CALL TO ORDER:

A special meeting of the Mayfield Town Board was held on Tuesday February 28th 2017 at the Mayfield Municipal Complex 28 N Main Street. The meeting was called to order at 10:00 AM and opened with the Pledge of Allegiance led by Supervisor Richard Argotsinger.

PUBLIC COMMENT: There were no public speakers

RESOLUTION #56 APPROVAL OF NEW HIGHWAY EMPLOYEE: A motion was made by Councilman Putman to approve David C Horning Jr. as a laborer in the Highway Department. The motion was seconded by Councilman Coletti. There was no discussion and the motion was approved with 5 ayes (Argotsinger, Coletti, Putman, Ruliffson, and Van Allen)

RESOLUTION #57 TO APPROVE TEAMSTERS AGREEMENT: Supervisor Argotsinger reviewed the agreement between the Town of Mayfield and Teamsters Local 294 as detailed in the written agreement between the two parties dated February 16, 2017. It was explained that the sanitation employees who are currently not part of the union had requested to join the Teamsters Union and that it would be in the best interest of both parties if they joined the existing union rather than negotiating two separate contracts. The Town agreed to not diminish the fulltime workforce of seven and all new hires are required to have a valid Class B CDL.

A motion was made by Councilman Putman and seconded by Councilman VanAllen to approve the contract. During discussion Highway Superintendent Dopp noted that overseeing the sanitation collection activities is not part of his legally required duties and stated that he had heard the stipend he currently receives for such duties would now be eliminated. Councilman Putman noted that the union agreement did not change his work load with respect to sanitation oversight. Supervisor Argotsinger stated there were no plans to eliminate that stipend. The motion was approved with 5 ayes (Argotsinger, Coletti, Putman, Ruliffson, and Van Allen)

PUBLIC COMMENT: There were no public speakers

RESOLUTION #58 TO MOVE INTO EXECUTIVE SESSION: A motion was made at 10:17 AM by Councilman Coletti and seconded by Councilman Putman to go into

executive session for employment history. There was no discussion and the motion was approved with 5 ayes (Argotsinger, Coletti, Putman, Ruliffson, and Van Allen)

RES#59 TO MOVE OUT OF EXECUITVE SESSION

On motion by Councilman Coletti seconded by Councilman VanAllen the following resolution was adopted 5 ayes (Argotsinger, Coletti, Putman, Ruliffson, and Van Allen) Let it be resolved that the Mayfield Town Board approves to move out of executive session and back into regular session at 11:45.

A lengthy discussion was conducted between Deputy Town Clerk Nancy Parker and the Board as to how to meet the resident's needs in the absence of the Town Clerk

On motion by Councilman Van Allen seconded by Councilman Coletti the meeting was adjourned at 11:54 AM 5 ayes (Argotsinger, Coletti, Putman, Ruliffson, and Van Allen)
