The regular monthly meeting of the Mayfield Town Board was held on November 10th at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 12117. The meeting was opened at 6:30 PM by Deputy Supervisor Roberta Ricciardi with the Pledge of Allegiance.

DEPARTMENT REPORTS:

CEO/BI - Damon Curley submitted the report stating 16 permits were issued in October, the Planning Board is meeting November 18th, Appearance Tickets were issued-but only able to site the zoning violations. There are multiple NYS Code violations that could have been sited, however the town has not officially adopted a law stating that I can enforce the NYS code violations. Continuing education with 2 more Code Enforcement classes taken. Councilwoman Mazzarelli questioned how long campers/RVs can be parked and used for summer camps and if any permits were required to do so. Damon stated he emailed a link from the planning board to all town board members regarding Short Term Rental Laws.

HIGHWAY SUPERINTENDENT- Jeff Martin submitted the report stating the roads have been salted twice, tree trimming is being done with a Gloversville Waterworks bucket truck on Nine Mile Tree Rd, Cemetery Rd, Gray Rd and Bemis Rd. Still working on FEMA projects. A trapper removed 5 beaver from Jackson Summit. 8 new tires are needed for the Garbage Truck. The new Garbage truck should arrive in January and the new Dump Truck should be here soon. Truck #3 has a lot of problems, new storm guards were put on #7. We have operators class on Friday with the State. We will also calibrate the Dickie Johns on Friday.

SUPERVISORS REPORT – Deputy Supervisor Roberta Ricciardi submitted the report stating 3rd quarter sales tax was up.

CEMETERY – The cemetery committee met and visited the cemetery regarding the placement of new grave stones. The committee will allow a flat, flush to the ground stone in the area in question. A letter will be sent to the lot owner stating the cemetery committee findings.
