# REGULAR MONTHLY MEETING NOVEMBER 13<sup>TH</sup> 2018

The regular monthly meeting of the Mayfield Town Board was held on November 13<sup>th</sup> 2018 at 6:30 PM at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 12117. The meeting was opened by Supervisor Argotsinger with the Pledge of allegiance.

PUBLIC COMMENT: None at this time.

#### **DEPARTMENT REPORTS:**

CEO: Mike Stewart submitted this report stating that 15 permits were issued in October and there were 4645 reported visits to the website. The Planning Board is meeting Wednesday, November 14<sup>th</sup> to review plans for a special use permit application for a solar farm on State Highway 29 near Nine Mile Tree Rd., and the soil excavation mine proposed by Roger Putman. Also completed 19 hours of required training at the NSBOC annual training conference.

HIGHWAY SUPERINTENDENT: Mel Dopp-absent, no report.

SUPERVISORS REPORT: Supervisor Argotsinger stated that the Association of Towns is having a meeting in New York City in February and if anyone was interested in attending he would provide the paperwork. New York State has required that a new Sexual Harassment Policy must be adopted. A copy from New York State Department of Labor and the Policy adopted by Fulton County was given to Councilman Coletti-Sexual Harassment Officer. Sales Tax went up for the 3<sup>rd</sup> quarter, mostly due to new solar installations. Mortgage Tax is down. The Village of Broadalbin has notified the Town of Mayfield that there are 4 streetlights on 3<sup>rd</sup> Ave with only one being in the village.

Councilman Putman questioned if the lights at the Vail Mills Roundabout have been repaired/replaced. MAC Electric is going to be doing the work for cost of bulbs/sensors and labor. National Grid supplies electricity to all light poles regardless if they are working or not.

# **OLD BUSINESS:**

TIMBER BIDS: The Timber Contract is in from the County and won't be signed until after the first of the year. Work will begin in the spring. The Town of Mayfield will receive 25% of the total price before work starts.

- (d) All money paid to the Fire Company shall be a charge against the taxable property in the Fire Protection district;
- (e) The contract shall be for a period of one year commencing January 1, 2019.

Mr. Mazzarelli explained that these lines are for the Village of Broadalbin residents only. This action usually requires a joint Public Hearing; but during discussions with the Town of Mayfield Attorney, it is possible to concede the parcels to the Village of Broadalbin with no such hearing.
