

REGULAR MEETING MAY 17, 2012

A regular meeting of the Mayfield Town Board was held on Thursday, May 17, 2012 at the Mayfield Municipal Complex 28 N School Street. The meeting was called to order at 7:00 PM and opened with the Pledge of Allegiance led by Supervisor Richard Argotsinger.

PUBLIC- Cliff Marcellus, 207 Yates Road stated to the board he worked for the highway department and was let go about a year ago and asked to have the nonsense stopped in regards to issues between the highway superintendent and himself.

CEO REPORT- Mike Stewart CEO submitted his monthly report which included 11 permits issued for the month and 5708 visits to the website. Planning Board had met and approved a site plan review for Dollar General Store on Bellen Road and a public hearing has been scheduled for June for a heavy equipment sales lot on Rte 30 next to the new hotdog business.

HIGHWAY- Mel Dopp Highway Superintendent submitted his monthly report which included guardrails will be up at the end of the month on Beech Street, new truck should be in next month, tractors are ready for mowing season; salt order has been placed for next winter with OGS. Thanked families that helped with roadside cleanup with the Fulton County Chamber of Commerce.
