

REGULAR MEETING APRIL 15, 2010

A regular meeting of the Mayfield Town Board was held on Thursday, April 15, 2010 at the Mayfield Municipal Complex 28 North School Street. The meeting was called to order at 7:00 PM and opened with the Pledge of Allegiance led by Supervisor Argotsinger.

PUBLIC- Jim Cownie thanked the town for being a site for income tax preparations. Jack Putman reported that he had visited a museum at the Fair Grounds in Syracuse has a large map and would like to sponsor a name plate there from Mayfield Mills & Furnaces for the Town of Mayfield.

CEO Report- Mike Stewart CEO submitted his monthly report for the month with 10 permits issued for the month, also attached his violation and complaints report.

HIGHWAY SUPERINTENDENT REPORT- Mel Dopp Highway Superintendent submitted his monthly report which included Tomantown Road residents would like road opened up to 4- wheelers, met with Chris Foss regarding Third Avenue, met with engineer regarding guard rails for Dennie Road, would like truck #2 out to bid next month, has 6 families lined up to do adopt a highway, gradall underinsured by 9 to 10,000. also expressed his displeasure with the town board over not receiving a letter that was received, feels he cannot get work done if he is not informed. Feels he is working 8 to 10 hours a day at this part time job, also stated he is sending a letter to the Leader Herald over his displeasure and gave each board member a copy of the letter.
