# REGULAR MONTHLY MEETING OCTOBER 8<sup>TH</sup> 2019

The regular monthly meeting of the Mayfield Town Board was held on October 8<sup>th</sup> 2019 at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 12117. The meeting was opened by Supervisor Richard Argotsinger at 6:30 PM with the Pledge of Allegiance.

## **DEPARTMENT REPORTS:**

HIGHWAY DEPARTMENT Mel Dopp, absent, no report given. The salt situation was discussed, the salt contract is back with Cargill, the garbage truck breakdowns were also discussed. There was a request for brush to be cut back on Proctor Rd, which is a seasonal road not open for motor vehicles. SUPERVISOR REPORT Supervisor Richard Argotsinger discussed the break down figures for the Summer Recreation Program stating that State Regulations is the reason for additional staffing/lifeguard positions, some mail is still going to 75 North Main St, insurance did go up but not as much as expected, and the County is still working on the 2020 Budget.

CEO Damon Curley entered the meeting at 6:40 pm and gave his report stating 18 permits were issued for September 2019, planning board approved a storage facility, other projects are moving along. Letters were sent for code violations, the box trailer law is complete and waiting approval from Carmel Greco Town Attorney and all training is complete and the CEO is now officially certified with 24 hours of training to be completed in 2020 to keep certification.

#### **NEW BUSINESS**

BUDGET WORKSHOP was opened at 6:52 PM and the Summer Recreation Program was discussed further. The Village of Mayfield requested an increase from \$6500 to \$8000 in contributions from the town. The current Budget is allowing an increase of \$1000 to \$7500 for the program.

A motion was made by Councilwoman Ricciardi to decrease the amount of Summer Recreation contribution from \$7500 back to \$6500 with no seconds.

# PUBLIC HEARING FOR LOCAL LAW # 6 Opened at 7:10 PM

The Public Hearing for Local Law # 6 – A local law Opting out of Section 487 NYS Real Property Tax Law Exemptions For Solar Energy Systems, Wind Energy System and Farm Waste Energy System Projects.

Be it enacted by the Town Board of the Town of Mayfield as follows:

SECTION 1. The purpose of this local law is to opt out of Real Property Tax Law Section 487 to capture tax revenues from the development of solar energy facilities and to

ensure that such facilities are treated equally with other commercial properties within the Town.

SECTION 2. A. No shall be applicable to exemption under Real Property Tax Law Section 487 shall be applicable to Town of Mayfield taxes with respect to any solar or wind

energy system or farm waste energy system.

B. No exemption under Real Property Tax Law Section 487 shall be applicable to Town of Mayfield taxes with respect to any micro-hydroelectric energy

system, fuel electric generating system micro-combined heat and power generating equipment system, or electric energy storage equipment or electric

energy storage system.

SECTION 3. The invalidity or unenforceability of any section, subsection, paragraph, sentence, clause, provision or phrase of the aforementioned sections, as declared

by the valid judgment of any court of competent jurisdiction to be unconstitutional, shall not affect the validity or enforceability of any other section,

subsection, paragraph, sentence, clause, provision or phrase, which shall remain in full force and effect.

SECTION 4. To the extent that this local law is inconsistent with Real Property Tax Law Section 487 it shall supersede those laws.

SECTION 5. Any and all prior Resolutions, Local Laws, rules and regulations of the Town which may be inconsistent or conflict with the provisions of this Local Law are

hereby repealed to the extent of such conflict or inconsistency.

SECTION 6. A. This law shall be effective immediately upon filing with the Secretary of State.

B. In accordance with RPTL 487 (8) A., the Tow shall file this local law with the commissioner of the New York State Department of Tax and Finance and with the president of the New York State Energy Research and Development Authority.
