REGULAR MONTHLY BOARD MEETING JANUARY 14TH, 2025

The Town of Mayfield held the Regular Monthly Meeting on January 14th, 2025, at 6:00 PM at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 1217. The meeting was opened by Supervisor Brandon Lehr with the Pledge of Allegiance.

PUBLIC COMMENT: Bob Murphy stated Vandenburgh Point Road is still not paved, stating that the stone dust applied did help but also created a lot of dust, and the potholes are big again. He also stated that a pipe to direct water flow off the road could be put in his yard. Michelle Johnsen stated that her neighbor is still building a very tall fence that blocks her lake view and questioned if anything would be added to laws or zoning to prevent this.

DEPARTMENT REPORTS:

Highway Superintendent Jeff Martin gave his report stating that the guys have been out plowing and salting frequently and presented the Board with an estimate of the truck to be ordered and needs a letter of intent to proceed with the purchase. CHIPS discussion and stated that he is fully staffed for the first time since taking office.

CEO/BI Norman Barbosa submitted his report stating 6 permits were issued, 15 inspections were completed, there has been a high success rate on complaint cases after new "NOV"-notice of violation template. Many calls about Sunset Bay Expansion Project, Planning Board meting had a record attendance in December with every seat taken. A fine was issued by NYS DOH for the Bellen Road property sewage problem.

Assessor Connie Henry submitted a report stating that she is still working with the iCloud permit system and the county. Fulton county will not send a live link to make the process easier for everyone. Exemptions are being returned and will be starting to enter them. Assessments have started, there is an in-person conference regarding a grievance on January 17^{th} . I will be out of the office February $10^{th} - 14^{th}$ and will seek coverage through Heather Kimball or Kristin Agerter.

Supervisor Brandon Lehr gave his report stating a letter was received from Adirondack Association of Town and Villages and forwarded to the Bookkeeper. Discussion about the pros and cons of the "Pro Housing" agenda from NYS. Councilman Desiderio voiced his concerns. Hours were discussed for the codes office with a change in office hours to 10:00am to 1:00pm.

The Town of Mayfield received a letter from the Association of Towns requesting a delegate to attend the Annual Business Meeting. Councilman Desiderio stated he has attended before and would do so again.
