I. FULTON COUNTY SEWER DISTRICT NO.2: VAIL MILLS

A. Background:

- In 2017, Fulton County established Fulton County Sewer District No.2: Vail Mills.
- In 2018, Fulton County began the construction of the sewer district's Sewer Collection and pumping system.
- Fulton County entered into an Intermunicipal Agreement with the Village of Broadalbin for use of the Village's wastewater treatment plant.
- Key aspects of that Intermunicipal Agreement include:
 1. The County's future investment into the expansion of the Village's wastewater treatment facility.
 2. The Village assumes ownership of all County installed infrastructure.
 3. The Village performs all of the Sewer District billing of users connected into the system.
