REGULAR MONTHLY MEETING APRIL 9TH 2019

The regular monthly meeting of the Mayfield Town Board was held on April 9th 2019 at the Mayfield Municipal Center, 28 N. School St. Mayfield NY 12117 at 6:30 pm and opened by Supervisor Richard Argotsinger with the Pledge of Allegiance led by Michael Stewart.

ALSO PRESENT: Michael Stewart, Attorney Carmel Greco, Sandra Town, Deb Dingman, Michelle Johnsen, Gary McCoy, Roberta Thomas.

PUBLIC COMMENT: Gary McCoy stated his unhappiness with the Highway Dept and the sweeping of the roads. He stated that he worked for a highway dept for 12 years and never swept debris onto lawns. He stated that his lawn has sand, chunks of blacktop and other road debris along the edge of his corner property on both sides. He also brought in photos of the road debris. He states that the highway dept should sweep into piles and clean it up or use different equipment that does not sweep the road debris onto lawns that meet the blacktop. He also questioned what to do with it after he cleans it up. He also had questions about lowering the speed limit on certain roads within the Jockeyville Rd. area. He was advised by the Mayfield Town Board the process to request a lower speed limit.

Others questioned the Mayfield Town Board as to why people who do not have the required CDL drivers license are driving town owned trucks and equipment.

Deb Dingman questioned the Mayfield Town Board as to zoning laws concerning her neighbors. States there is a trailer (from a tractor-trailer) right on the property line that is falling apart and several other eye sores in the neighbors yard.

Sandra Town notified the Mayfield Town Board that as Town of Mayfield Historian she was contacted by many people about the removal of stone walls throughout town, and stated that many were very unhappy about seeing the stone walls destroyed. Lengthy discussion about this topic and how to prevent it from happening in the future.

DEPARTMENT REPORTS:

CEO Mike Stewart gave his report stating 4 permits were issued in March, there were 4665 visits to the website. The proposed Solar Farm on St. Hwy 29 near Nine Mile Tree Rd is on hold pending more review and possible revisions. The addition to Centore Granite and Marble is still being reviewed. Damon is completing necessary training.

HIGHWAY SUPERINTENDENT Mel Dopp – Absent, left report stating the Highway Dept is out sweeping roads and patching potholes, doing all painting and repairs on trucks, picking up garbage on right of ways. Tomantown Bridge will remain closed.

The Town of Mayfield received a grant to switch street lighting to LED in the amount of \$2,270.00. Dog and Cemetery reports were received and Workers Compensation report was also received Discussion about computer updates required for the Town of Mayfield.
