# **DEPARTMENT REPORTS:**

CEO/BI Damon Curley submitted his report stating 9 permits were issued, the Planning board will meet to continue discussions of the proposed RV park on Route 20 and Woods Hollow Rd. Blight letters were sent out, there is a proposed addition to Sunset Bay Resort Dave Huckans, the owner of Paradise Point has agreed to keep the infrastructure as part of the HOA, and requires a letter from the board stating that the town does not have the capabilities to maintain and repair the sewer system.

HIGHWAY SUPERINTENT Jeff Martin submitted his report stating the town went out four times to plow/salt roads, maintenance has been done on trucks, snow fence was placed in front of cemetery gates. The bucket truck from Northville needs to be put on the road, an no one has applied for the part time position. Paving paperwork is complete and handed in to the State. The light pole is missing from the roundabout at state route 29 and 30, and no parts for it have been received yet.

RESOLUTION ESTABILSHING TYPE CAPITAL RESERVE FUND FOR REFUSE EQUIPMENT RES #132 On motion by Councilman Coletti, seconded by Councilman Ruliffson the following resolution was adopted 3 AYES (Argotsinger, Coletti, Ruliffson)

RESOLVED that pursuant to Section 6-c of the General Municipal Law, as amended, there is hereby established a capital reserve fund to be known as the "Refuse Equipment Fund" (hereinafter "Reserve Fund"). The purpose of this Reserve Fund is to accumulate moneys to finance the cost of the refuse equipment. The type of equipment to be financed from the Reserve Fund is the acquisition of refuse equipment.

The Chief fiscal officer is hereby directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The governing board may invest the moneys in the Reserve Fund in the manner provided by Section 11 of the General Municipal law, and consistent with the investment policy of the Town of Mayfield. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve Fund. The chief fiscal officer shall account for the Reserve Fund in a manner which maintains the separate identy of the Reserve Fund and shows the date and amount of each sum paid into the fund, interest earned by the fund, capital gains or losses resulting from the sale of investments of the fund, the amount and date of each withdrawal from the fund and the total assets of the fund, showing cash balance and a schedule of investments, and shall, at the end of each fiscal year, render to the board a detailed report of the operation and condition of the Reserve Fund.

Except as otherwise provided by law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. No expenditure shall be made from this Reserve Fund without the approval of this governing board and such additional actions or proceedings as may be required by Section 6-c of the General Municipal Law or any other law, including a permissive referendum if required by subdivision 4 of Section 6-c.
