Supervisor Argotsinger reported that he would like to recommend we have a policy in regards to appointment to Planning Board, Zoning Board and Board of Assessment Review Board. A suggestion of having 2 town board members and 2 members of the board come up with a name to come to the town board for recommendation to fill the position.

Resident Jack Putman stated he has a problem with people from the the existing board appointing board members.

A discussion followed and Councilman Humphrey will draft a policy for the board to review.

Res# 62 OPPOSING CLOSURE OF TRYON RESIDENTIAL CENTER

On motion by Councilman Coletti seconded by Councilman Ruliffson the following resolution was ADOPTED 5 AYES (Argotsinger, Coletti, Humphrey, Ruliffson, Van Allen)

WHEREAS, Governor Paterson's proposed Executive State Budget identifies closure of the Tryon Residential Center, located in the Town of Johnstown; and

WHEREAS, Tryon Residential Center has a long tradition of service to troubled youth and to the community at large; and

WHEREAS, closure would remove a important option from the Office of Children and Family Services system and have a detrimental impact on the local economy, including the loss of approximately 150 jobs; now, therefore be it

RESOLVED, That the Town Board of the Town of Mayfield hereby opposes closure of the Tryon Residential Center and urges Governor Paterson and the NYS Legislature to reinstate appropriate funding for the Tryon Residential Center in any adopted State Budget for 2010-2011; and, be it further

RESOLVED, That certified copies of this Resolution be forwarded to the Governor David Paterson, Senate Majority Leader Pedro Espada, Jr., Senator Hugh Farley, Assembly Speaker Sheldon Silver, Assemblyman Marc Butler, NYS Officer of Children and Family Services, Fulton County Chamber of Commerce, Administrative Officer/Clerk of the Board and to each and every other person, institution or agency who will further the purport of this Resolution.

ADIRONDACK WATERSHELD STUDY- Supervisor Argotsinger reported he has received many mailings and e-mails on this.

COMPREHENSIVE PLAN- Councilman Coletti and Councilman Humphrey will review the plan and suggest any changes they see fit.
