# REGULAR MEETING SEPTEMBER 20, 2012

A regular meeting of the Mayfield Town Board was held on Thursday, September 20, 2012 at the Mayfield Municipal Complex 28 N School Street, Mayfield.

The meeting was called to order at 7:00 PM and opened with the Pledge of Allegiance led by Supervisor Richard Argotsinger.
