The regular meeting of the Mayfield Town Board was held on Tuesday, August 8th 2017 at 6:30pm and opened by Supervisor Argotsinger with the Pledge of Allegiance.

DEPARTMENT REPORTS:

CEO Mike Stewart submitted his monthly report which includes 8 permits issued in July. The Town had 7135 visits to the website. The planning board approved a replacement addition at the Bobcat Dealership on St. Rte 29. Discussion about the Huckans project. Discussion about drop in website visits.

HIGHWAY SUPERINTENDENT Mel Dopp (Absent) has forwarded his monthly report.

SUPERVISOR Richard Argotsinger stated that the insurance premium is going up by about \$1000.00. A letter was received from the NYS Dept. of Ag and Markets stating that the James a Brennan Humane Society has passed their annual inspection. Second quarter sales tax is down. The County Budget process will start next week. There will be a pre-October budget meeting with the entire Town Board. Brief discussion about the budget process.

RESOLVED that the Mayfield Town Board will hold a PUBLIC HEARING on September 13th 2017 at 6:45pm on the following LOCAL LAW NO. 1 of the year 2017 Authorizing Raffles in the town of Mayfield.

Section 1. TITLE

This Local Law shall be known as: "A Local Law Authorizing Raffles in the Town of Mayfield".

Section 2. DEFINITIONS

Unless the context otherwise requires, the meaning of the terms used in their Local Law shall be as follows:

AUTHORIZING ORGANIZATIONS – An authorized organization as defined in subdivision 4 of Section 186 of the General Municipal Law.

GAMES OF CHANCE, LIMITED TO RAFFLES – Games of chance, limited to raffles as defined by subdivision 3-b of Section 186 of the General Municipal Law.

Section 3. GAMES OF CHANCE, LIMITED TO RAFFLES, AUTHORIZED

Any authorized organization may conduct games of chance, limited to raffles, within the town of Mayfield as provided further in this Local Law. Such games of chance shall be conducted in accordance with the laws of the State of New York and with the rules and regulations adopted by the New York State Racing and Wagering Board.

Section 4. PENALTIES FOR OFFENSES

Any willful violation of any provision of this Local Law shall constitute and be punishable as a misdemeanor as provided in Article 9-a, Subsection 195-k of the General Municipal Law.

Section 5. EFFECTIVE DATE

This Local Law shall not become effective unless and until it shall have been approved by a majority of the electors voting on a proposition submitted at a general or special election held within the town of Mayfield who are qualified to vote for officers of the town and thereafter filed in the office of the New York State Secretary of State.
