Also worked on Tolmantown Rd and has put in culverts on Riceville Road. Mel also reported that the state is still working on speed limit reduction on St Hwy 30 and St Hwy 349. 4 dumpsters filled today at clean up days. Received a letter from resident on Woods Hollow rd regarding culvert installation, forward to highway committee for review. Also the town has been working at the beach.

SUPERVISOR – Supervisor Argotsinger reported that the 1<sup>st</sup> quarter sales tax check was received in the amount of \$148,862.39 NYMIR informed the town that rates will decrease for 2015 by small percentage. Also received letter from American Power & Gas informing the town their rates will increase. A small discussion followed with the town deciding to stay with Niagara Mohawk. Also notified from Board of Elections that the town has 2 vacancies this year with petitions picked up May 29<sup>th</sup> which is also the first day for signatures with filing dates of July 7-10<sup>th</sup>.
