

## REGULAR MONTHLY MEETING MAY 9<sup>TH</sup> 2023

The Mayfield Town Board held a Regular Monthly Meeting on May 9<sup>th</sup> 2023 at 6:30 PM at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 12117. The meeting was opened by Supervisor Richard Argotsinger with the Pledge of Allegiance.

PUBLIC COMMENT: Rich Roberti addressed the board with rumors about Vandenburg Point Rd Ext. Lengthy Discussion about the road and rumors.

### DEPARTMENT REPORTS

CEO/BI Damon Curley – Absent, left report stating 18 permits were issued, the Zoning board is reviewing 3 different properties, and the Zoning Review is still continuing. Also working on 6 different blight issues.

HIGHWAY SUPERINTENDENT Jeff Martin gave his report stating that the FEMA funds from the Gray Rd Culvert project were in and the paving bids were in with only one bid submitted.

Highway Superintendent also stated that the pad is done for the salt shed, the leased tractor has arrived and has been out brush hogging where needed. The mower is expected to arrive soon.

Councilman Ruliffson suggested when things slow down the Highway Department could straighten, and repair and paint the historical signs in town.

SUPERVISOR Richard Argotsinger gave his report stating that the Teamsters Union sent a letter stating that there is a new local representative. The Penalty monies of Town and County Taxes has been paid to the supervisor in the amount of \$8,437.32.
