PUBLIC- Betty Tabor, Historian reported that she will be having an exhibit at the Mayfield Library on the 50th anniversary of the Great Sacandaga Lake.

DEPARTMENT REPORTS-

DCO- Supervisor Hart reported that she had received a letter regarding the redemption of dogs from our town shelter from NYS Ag & Mkts.

HIGHWAY REPORT- Councilman Ryan reported that Precision Environmental had tested the contaminated soil at the Highway Department and they were satisfied with the results for transportation of soil. Councilman Ryan had contacted the DEC for necessary paperwork to be able to transport the soil to Mud Road.

CODE ENFORCEMENT REPORT- Mike Stewart CEO submitted his monthly report which included 17 permits for the month of August.

BEAUTIFICAN GRANT PROGRAM- Councilman Ryan explained the program and reported that three applications had been received, reviewed and approved by the committee.

MUNICIPAL BUILDING- Supervisor Hart reported that the agreement has been forwarded to the Town attorney. Also she and Mike Stewart, CEO and board members had met with George DiMarco from Fulton County Planning Department and did a walk thru on the Fire District building. Some issues were discussed such as the placement of the elevator, making the bathroom's handicap accessible, exit lights and railings on the stairs.

Mike Stewart CEO submitted a scheme D layout of the building. A small discussion followed with the board approving the layout.

CORRESPONDENCE

Ed Himes submitted a copy of a letter that was in the Leader Herald regarding the need for traffic lights on State Hwy 30 between Second Avenue and North Main Street in the Village. He would like the town board to help in trying to gain these before someone gets killed trying to get onto St Hwy 30. Supervisor Hart reported that the Route 30 Corridor Study will be meeting on September 16th and she would contact Mr. Hime and advise him.
