A special meeting of the Mayfield Town Board was held on Tuesday, November 30, 2010 at 11AM at the Mayfield Municipal Complex 28 N School Street and opened with the Pledge of Allegiance led by Supervisor Argotsinger.

RES# 191 CHANGING EAST SIDE OF BLUEBIRD LANE TO HUMMINGBIRD LANE

On motion by Councilman Van Allen seconded by Councilman Coletti the following resolution was ADOPTED 5 AYES (Argotsinger, Coletti, Humphrey, Ruliffson, Van Allen)

RESOLVED that the Mayfield Town Board approves to change the east side of Bluebird Lane to Hummingbird Lane, which Hummingbird Lane would be heading south to a right hand turn heading west to the other half of Bluebird Lane, which is .29 tenths. Bluebird will continue North to Rt. 29A and Hummingbird will be starting on 29A.

Melissa Mazzarelli Assessor reported that Stone Jug Road is not a 911 road. A discussion followed and a meeting will be held on Thursday, December 9th at 10AM with Garth Hillier from the Sherriff's Department, Mel Dopp Highway Superintendent and Melissa to go over the road names. Supervisor Argotsinger invited any board members that would like to attend.

A discussion was held on a payroll issue that occurred last week. It was decided to have the policy committee, highway committee and the Highway Superintendent draft a job description for the sanitation department.

Supervisor Argotsinger reported that an oversight on the insurance deductible paperwork has delayed members receiving their necessary paperwork that takes effect on Wednesday December 1st.

Mel Dopp Highway Superintendent reported that the fire district would like to give the town a generator and perhaps in exchange for doing the paving on the parking lot. A discussion followed with Councilman Van Allen and Mel Dopp Highway Superintendent to attend the Fire Commissioners meeting on December 15th and then will report back to the town board on December 16th.
