### **DEPARTMENT REPORTS**

CEO Mike Stewart submitted his monthly report which includes 5 permits in April. The town had 7373 visits to the website. The Planning Board approved a Sub-Division on Sand Hill Rd. the Zoning Board had their public hearing and the Board of Appeals will meet later this month.

HIGHWAY SUPERINTENDENT Mel Dopp reports that 3 culverts were fixed on Tolmantown Rd along with new gravel and c learing down trees. All plows and wings were painted. 5 culverts were put in throughout the town and ditches are being being dug out and shoulders are being cut back. No littering signs were put up in 2 locations. Extra CHIPS money will pave another mile of road. Mel stated that the garbage pickup rules need to be posted on the website or in the newspaper again.

Attorney Carmel Greco entered the meeting at 6:35pm

SUPERVISOR Richard Argotsinger stated he attended all county meetings. Sales tax for the first quarter is \$260,509.17 which is up from last years first quarter by \$21,803.84. The budget process for next year has already started at the county level. Consolidation of Services meeting is May 22<sup>nd</sup> and is open to the public.

### **NEW BUSINESS**

Mr. Roy Sweet spoke on behalf of the Ambulance Service of Fulton County in regards to Ambulance Service in the Vail Mills area of Mayfield. Currently that area is covered by Broadalbin Ambulance. Mr. Sweet states that BVAC is not always staffed to answer calls, and may enter contracts with GAVAC, which will mean a longer response time. ASFC left the meeting at 7:07pm.
