The regular meeting of the Mayfield Town Board was cancelled for March 14th 2017 due to heavy snow. The regular meeting was held on Wednesday, March 15th 2017 at 10:00am and opened with the Pledge of Allegiance led by Supervisor Argotsinger.

DEPARTMENT REPORTS

CEO Mike Stewart submitted his monthly report which included 1 building permit for a solar installation. The town had 8448 visits to the website in February. The planning board will meet tonight to schedule a public hearing for a subdivision.

HIGHWAY SUPERINTENDENT Mel Dopp reports that the highway dept. worked with National Grid cutting down about 50 trees in town and also chipped brush and limbs from trees that fell during the last storm. Truck maintenance was done. 8 hours of safety training was done for all dept. personnel. Mel stated that he has posted the weight limit signs in town but needs board approval.
