## VARIANCE APPLICATIONS

## 1. Catino Samperi

An application was submitted January 6, 2005, by Catino Samperi for property located on Kunkel Point Road, SBL#104.18-4-21. He is proposing to demolish an existing house and construct a new Single Family home. This proposal does not comply with Local Law #1-1985, Section 2.2, as it applies to a 15(fifteen) feet setback. CARRIED 4(four) AYES 0(zero) NAYS.

## 2. Robert McCloskey

An application was submitted January 2, 2005, by Robert McCloskey for property located on Route 29. SBL#152-4-1. He is proposing to construct and place 6(six) Billboards (four 10' by 20' V type, two 10' by 20' single faced) on the property. This proposal does not comply with Local Law #3-2003, Section 2, as it applies to the erection of signs exceeding 40(forty) square feet. The Board discussed the application and a motion to schedule a Public Hearing for Mr. McCloskey on February 23, 2005 at 7:20 p.m. was made by Myrna Hallenbeck, seconded by James Rulison. CARRIED 4(four) AYES 0(zero) NAYS.
