

REGULAR MONTHLY MEETING FEBRUARY 14TH 2023

The Mayfield Town Board held a Regular Monthly Meeting on January 10th 2023 at 6:30 PM at the Mayfield Municipal Complex, 28N. School St. Mayfield NY 12117. The meeting was opened by Supervisor Richard Argotsinger with the Pledge of Allegiance.

PUBLIC COMMENTS: None at this time.

DEPARTMENT REPORTS:

CEO/BI Damon Curley – Absent – no report given.

Highway Superintendent Jeff Martin gave his report stating all the light bulbs are changed at the Vail Mills traffic circle, except the broken pole which will be done in the spring. A new salt shed was discussed.

RES #36 On motion by Councilman Ruliffson, seconded by Councilman Desiderio the following resolution was adopted 4 AYES (Argotsinger, Desiderio, Putman, Ruliffson) 1 NO (Mazzarelli)

RESOLVED that the Mayfield Town Board will put out to bid the materials for construction of a salt shed with bids to be returned to the Town of Mayfield by April 3rd 2023 at 12:00 PM.

The Highway superintendent was approached by the county about taking back the county roads to plow. They did not meet the requested price per mile.

Discussion about the equipment currently leased and equipment to be leased in the future such as a loader.

RESOLVED that the Mayfield Town Board authorizes the Supervisor to sign the lease contract for a 2023 Case 621G Wheel loader for 3 years.

RES #38 On motion by Councilwoman Mazzarelli, seconded by Councilman Ruliffson the following resolution was adopted 5 AYES (Argotsinger, Desiderio, Mazzarelli, Putman, Ruliffson)
RESOLVED that the Mayfield Town Board authorizes the Supervisor to sign the agreement with Auctions International for 2023.

RES # 39 On motion by Councilwoman Mazzarelli, seconded by Councilman Putman the following resolution was adopted 5 AYES (Argotsinger, Desiderio, Mazzarelli, Putman, Ruliffson)
RESOLVED that the Mayfield Town Board authorizes the Supervisor to sign the lease contract for a JD Tractor with boom mower for 2023.

SUPERVISORS REPORT – Supervisor Richard Argotsinger gave his report stating that CT Male has filed their annual report for the Landfill Closure. Also that the Vail Mills sewer project is coming along and close to being completed.

OLD BUSINESS

COURT SECURITY – Town attorney Carmel Greco is determining if the Town of Mayfield can have a Town Constable Position. There will be a meeting at a later date.

AIR CONDITIONING – We have one bid with hopes of more coming in soon.

COMMERCIAL FEES FOR CONSTRUCTION – Lengthy discussion about fees for large commercial projects and fees associated with the construction of solar farms. Councilman Desiderio stated that he checked with several other towns and they all have different fees per kilowatt installed. Councilwoman Mazzarelli stated she needed and will seek more information.

RES #40 On motion by Councilwoman Mazzarelli, seconded by Councilman Ruliffson the Putman the following resolution was adopted 4 AYES (Argotsinger, Mazzarelli, Putman, Ruliffson) 1 NO (Desiderio)

RESOLVED that the discussion and setting of fees for commercial construction will be tabled until the March 14th meeting.

NEW BUSINESS

BROADALBIN/MAYFIELD CEMETERY

Discussion about the Broadalbin/Mayfield Cemetery and amount budgeted for the town portion.

RES #41 On motion by Councilwoman Mazzarelli, seconded Councilman Putman the following resolution was adopted 5 AYES (Argotsinger, Desiderio, Mazzarelli, Putman, Ruliffson)

RESOLVED that the Mayfield Town Board will send the cemetery association a check for \$2000 that was budgeted for 2023.

PLANNING BOARD ALTERNATE

Supervisor Argotsinger spoke with John Kessler, Chairman of the Mayfield Planning Board and feel the planning board only needs one Alternate.

EMAIL ACCOUNTS MIGRATION COST

Councilman Desiderio stated everyone has legitimate email accounts now but that better security for them is needed.

RES #42 On motion by Councilwoman Mazzarelli, seconded by Councilman Ruliffson the following resolution was adopted 5 AYES (Argotsinger, Desiderio, Mazzarelli, Putman, Ruliffson)

RESOLVED that the Mayfield Town Board will update the security for email accounts.

Councilman Desiderio stated that the old computers that were replaced by new laptops were wiped clean and will destroyed or purchased by the previous users of the same computers, with the exception of one old laptop to be used by the Deputy Town Clerk for internet related purposes.
