REGULAR MONTHLY MEETING NOVEMBER 12TH 2019

The regular monthly meeting of the Mayfield Town Board was held on November 12th 2019 at 6:30 PM at the Mayfield Municipal Complex, 28N School St. Mayfield NY 12117. The meeting was opened by Supervisor Richard Argotsinger with the Pledge of Allegiance.

PUBLIC COMMENT

Randy and Bonnie VanNostrand questioned the board about the lack of maintenance on Tyrrell Rd. The road was washed out during a storm and left them stranded. They have concerns about emergency vehicles being able to get to them. Tyrrell Rd is a Town Rd, and the sign stating it is not, was placed there in error.

DEPARTMENT REPORTS

CEO Damon Curley gave his report stating that 20 permits were issued in October and the Board should revisit the permit pricing; the Planning Board will review Borrego Solars Landscaping and Decommissioning plans for the Solar Project on State Highway 29; Pauls Autobody is approved and should be open by December 1, 2019; Sacadaga Brewing should begin brewing by the first of the new year; and a fire destroyed 228 Riceville Rd, and it is questionable if it can be saved. Also, several other complaints have been answered, weeds and trash, illegal junkyards and campgrounds. Still looking for input for future Air BnB laws from the committee. The box trailer law is being reviewed by the Town Attorney Carmel Greco.

All interested in the matter shall be heard at such time and place.

HIGHWAY DEPARTMENT Mel Dopp, absent, no report. The Highway Committee felt that the leased equipment could have been taken care of better than it was.

SUPERVISOR REPORT Supervisor Richard Argotsinger stated that the County had a Tentative Budget in place. Ralph DeSiderio had questions about the tax rate and equalization rates. Sales tax went down for the 3rd quarter, mortgage tax went up. There have been complaints about recently paved roads not being lined, the county states they were never notified by the Highway Department of which roads needed to be lined. Renate VanNostrand stated that Yates Rd was hard to drive in the dark/rain, and it is a safety issue. Supervisor Argotsinger thanked everyone up for election for taking their signs down promptly.
