

## REGULAR MONTHLY MEETING AUGUST 11<sup>TH</sup> 2020

The regular monthly meeting of the Mayfield Town Board was held on August 11<sup>th</sup> 2020 at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 12117. The meeting was opened at 6:30 PM by Supervisor Richard Argotsinger with the Pledge of Allegiance.

PUBLIC COMMENT: None at this time.

### DEPARTMENT REPORTS

CEO/BI – Absent – no report

HIGHWAY DEPARTMENT – Highway Superintendent Jeff Martin submitted his report stating all the paving is complete for \$140,000 and the paved roads have already been shouldered. Ditching and cutting shoulders back, and completing second round of mowing which will probably be the last. Still working with FEMA and all of the projects are done except Gray Rd. Water main leak and power problem have been fixed. When weather cools trees will be trimmed that are hanging over roadways with the use of the Gloversville Waterworks bucket truck. There is one new hire with one part time position left to fill. The Highway Department has no fire alarms at that location. Oil changes and routine maintenance for winter months will start soon.

RES #121 On motion by Councilman Coletti, seconded by Councilman Ruliffson the following resolution was adopted 5 AYES (Argotsinger, Coletti, Mazzarelli, Ricciardi, Ruliffson)

RESOLVED that the Mayfield Town Board approves the hiring of one part time employee.

Discussion about the ditches and signs on Gray Rd and the flag pole or lack of at the court/highway department. The Highway Department will pressure wash the court building at the request of Justice Papa.

SUPERVISORS REPORT – Supervisor Richard Argotsinger submitted his report stating that sales tax was only down by just over \$ 9,000 which the projected loss was approximately \$ 100,000. Met with Morlex Solar to discuss projects in the area including a 900 acre project in Perth. Workman's Comp is up as expected. Letter From Ron Schur about kids jumping off the School Street Bridge into the lake. Spoke with the Town of Northampton about the purchase of a safe owned by them.

RESOLVED that the Mayfield Town Board approves the purchase of a safe from the Town of Northampton not to exceed \$ 1500.

### OLD BUSINESS

INVENTORY – Councilman Coletti stated that the inventory is almost complete with only a few departments left to be completed.

ACCOUNTING OF THE RECORDS – Councilwoman Mazzarelli and Councilwoman Ricciardi have the Bookkeeper and the Clerk to finish.

## NEW BUSINESS

LIGHTING –Discussion about the lighting contract at the State Highway 30 and 30A roundabout.

RESOLVED that the Mayfield Town Board authorizes the Supervisor to sign the contract for the State Highway 30 and 30A roundabout on approval by the Town Attorney.

RECORDS RETENTION SCHEDULE – The Clerk was notified that the New York State Archives is revising and consolidating its local government records retention and it must be adopted before utilizing the schedule. The new retention schedule was available August 1<sup>st</sup> 2020.

A local law To Override the Tax Levy Limit Established in General Municipal Law 3 – c for Calendar Year 2021. Be it enacted by the Town Board of the Town of Mayfield as follows:

The Text of this Local Law is annexed hereto.

Local Law No. 3 of the year 2020

Town of Mayfield, County of Fulton

A local law to override the tax levy limit established in General Municipal Law 3 – c; Be it enacted by the Town Board of the town of Mayfield as follows:

#### Section 1. Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Mayfield pursuant to the General Municipal Law 3 – c, and to allow the Town of Mayfield to adopt a budget for the fiscal year 2020 that requires a real property tax levy in excess of the “tax levy limit” as defined by General Municipal Law 3 – c.

## Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law 3 – c, which expressly authorizes the Town Board to override the tax cap by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board.

## Section 3. Tax Levy limit Override

The Town Board of the Town of Mayfield, County of Fulton is hereby authorized to adopt a budget for the fiscal year 2021 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law, 3 – c.

Section 4. Severability. If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgement shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment of order shall be rendered.

## Section 5. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.
