

REGULAR MONTHLY MEETING APRIL 11TH 2023

The Mayfield Town Board held a Regular Monthly Meeting on April 11th, 2023, at 6:30 PM at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 12117. The meeting was opened by Supervisor Richard Argotsinger with the Pledge of Allegiance.

PUBLIC COMMENTS: Melinda Girard spoke on behalf of the people and neighbors about a hoarding situation across the road from their house at 550 Co. Hwy 123. A lengthy discussion about the animals in the house and on the property along with a small little girl that lives there. CPS has been called, along with the Dog Control Officer. Steve Girard spoke about the blight and asked what could be done about that. Pat Conca also spoke on this situation and stated that he is selling his house because of it. CEO/BI Damon Curley stated he would do what he could to try to help them. Bob Murphy asked if there were any new developments on the survey on Vandenburg Point Rd. Ann Connolly spoke up and had a lengthy printed speech about the survey that was done on Vandenburg Point Rd. She stated that she was not made aware of the survey and there are no survey stakes where it took place. Highway Superintendent Jeff Martin stated he would check into that when he goes to the county building. Ann Connolly also spoke about the short-term rental laws.

DEPARTMENT REPORTS:

CEO/BI Damon Curley submitted his report stating that he issued 13 permits, and the planning board is meeting April 19th for lot line adjustments, minor subdivisions, and storage facilities. Also working on blight and other issues.

HIGHWAY SUPERINTENDENT Jeff Martin submitted his report stating that he has a list of paving for this summer, the plows are all off the trucks, he expects the new 6500 truck to be here the end of April, the bids are in for the salt shed and he commented that many street signs are missing around town. Councilwoman Mazzarelli questioned how many roads are usually paved and that the salt shed was not a budgeted item and would like to know where the money is coming from for it. Lengthy discussion on salt shed and paving.
