REGULAR MONTHLY MEETING AUGUST 14TH 2018

The regular monthly meeting of the Mayfield Town Board was held on August 14th 2018 at 6:30 PM at the Mayfield Municipal Complex, 28 N. School St. Mayfield NY 12117. The meeting was opened by Supervisor Argotsinger with the Pledge of Allegiance led by Mike Stewart.

PUBLIC COMMENT: None at this time.

DEPARTMENT REPORTS:

CEO – Mike Stewart reports issuing 12 permits in July. There were 9473 visits to the website. The Planning Board approved a lot line adjustment between Pearl Meadow Stables and Jeffrey Edwards for the property located on Warren Rd. Short Term Rental regulations have been sent out, some fees and applications have been returned. Solar Farm regulations will be sent to the planning board along with a request for a zoning change for My Garage on Griffis Rd.

Town Attorney Carmel Greco entered the meeting at 6:35 PM

HIGHWAY SUPERINTENDENT - Mel Dopp, Absent. Left report stating mowing, including cemeteries, cutting trees including storm damage, also patching roads. Heard complaints about the beach road, worked on trucks and equipment, cleaned shop.

SUPERVISOR – Richard Argotsinger states that the Municipal Shelter passed its Ag & Markets inspection, the equalization rate for 2019 will be 68%, the Town Beach passed the NYS Health Dept. inspection, sales tax was up for the second quarter by \$32,177.16 from this time last year. Workers Comp will go up \$21,000.00 in 2019.

NEW BUSINESS:

NYS Gaming Commission Raffle Law discussion. Town law has no provision for issuing "Gaming Licenses" to sell raffle tickets within the town. No action will be taken at this time per Town Attorney Carmel Greco.

Paving – The winning bidder has asked the Town Board for an extension on the deadline to pave. As per Town Attorney Carmel Greco, it is in the best interest of the Town to void the paving contract at this time.

NATIONAL GRID LIGHTS

Supervisor Argotsinger received a letter from National Grid stating that the light on the corner of State Highway 349 and State Route 30 is not on their inventory and the town has never paid for it. Letter states that it has to added to the inventory and billed to the town or removed.

TOWN COURT

Supervisor Argotsinger received an email from Justice Marjorie Jones stating they would like to have an "In Court Charge Card Reader". The contract was reviewed by Town Attorney Carmel Greco and was found to be acceptable. There will be no charges to the Town of Mayfield; fees will be paid by defendants who chose to use a charge card for fines and court fees.

The letter states that Mr. McGuire would like the board to reconsider the zoning at that Griffis Rd. address as his property is for sale and he has lost a sale due to the current zoning.
