DEPARTMENT REPORTS:

HIGHWAY SUPERVISOR Jeff Martin gave his report stating all paving is done, majority of shouldering roads with rubble is done, helped Town of Oppenheim and Northampton with paving, took some trees down on Handy Road, replaced culvert pipe on Christie Road, bids are out for waste blocks, put a culvert pipe in on Kunkel Pt Road, truck #7 water pump has been replaced, back up mowing again the side of the roads, mowing the beach and the old dump, and completed some ditching.

SUPERVISORS Rick Argotsinger gave his report stating he received a letter from the Air Force saying they will be training at HRBRD, The Adirondack local review is asking for a \$300 donation, the county gives them a \$3000 donation. Broadalbin fire department state exemption was discussed, Sales tax is up (\$455420.90) is up from last year 10.4%. Workmen's comp passed at the county up from last year 2.7%

OLD BUSINESS: Discussed cemetery lighting and Plexi glass windows, cemetery committee will have to decide what is best.
