Section 4 of Local Law No. 3 of the year 2008 is hereby amended by adding a subparagraph which is to read as follows:

(a) Pursuant to subsection 2(c)(iii) of \$458-b of the NYS Real Property Tax Law, the exemption authorized shall apply to qualifying owners of qualifying real property for as long as they remain qualifying owners, without regard to such ten year limitation.

## Section 3. Effective Date

This Local Law shall take effect immediately upon its filing with the Secretary of State and shall be applicable to all assessment rolls prepared pursuant to the first taxable status date occurring on or after the effective date of this Local Law.
