SECTION 1. Purpose

The purpose and intent of this Local Law is to amend the Zoning Law of the Town of Mayfield, also known as Local Law No. 2 of the year 2005, as hereinafter provided, and to amend the Town Zoning Map accordingly.

SECTION 2. Amendment

The following properties situate on the west side of New York State Route 30, presently classified, zoned and designated "Agricultural" (AG), shall be and are hereby reclassified, zoned and designated "Commercial" (C-1) under the Town of Mayfield Zoning Law which was duly adopted on August 17, 2005, subject to all regulations created and established relative to a Commercial (C-1) District:
