## SECTION 1. LEGISLATIVE INTENT

The intent and purpose of this Local Law is to provide for the appointment of alternate members to serve on the Town Planning Board, pursuant to the authority set forth in Section 271, paragraph 15, of the Town Law of the State of New York. It is also intended to supplement the provisions set forth in Local Law No. 3 of the year 1994 and Local Law No. 2 of the year 1998.

# SECTION 2. ALTERNATE MEMBERS

In addition to the five (5) regular members of the Town Planning Board, as provided for in Local Law No. 2 of the year 1998, there shall be two (2) alternate members of the Town Planning Board who shall be appointed by resolution of the Town Board, for terms established by the Town Board.

#### SECTION 3. DUTIES OF ALTERNATE MEMBERS

The chairperson of the Town Planning Board may designate an alternate member of the Town Planning Board to substitute for a regular member when such regular member is unable to participate because of: (a) a conflict of interest, (b) absence or (c) disability, any of which would prevent any such regular member from considering any pending matter. When so designated, the alternate member shall possess all the powers and responsibilities of such regular member of the Town Planning Board. Such designation shall be entered into the minutes of the initial Planning Board meeting at which the substitution is made.

## SECTION 4. ADDITIONAL PROVISIONS

All of the provisions contained in Section 271 of the Town Law of the State of New York relating to planning board member training and continuing education, attendance, conflict of interest, compensation, eligibility, vacancy in office, removal, and service on other boards, shall also apply to alternate members.

# SECTION 5. EFFECTIVE DATE

This Local Law shall take effect immediately upon filing in the office of the New York Secretary of State, in accordance with the provisions of the Municipal Home Rule Law of the State of New York.
