INTENT:

IT IS THE INTENT OF THIS BID PROPOSAL TO SOLICIT BIDS FOR MATERIAL, EQUIPMENT AND LABOR TO RESURFACE WITH ASPHALT CONCRETE VARIOUS ROADS WITHIN THE TOWN OF MAYFIELD, THE SUCCESSFUL BIDDER WILL FURNISH ALL MATERIALS, LABOR AND EQUIPMENT TO DELIVER, PLACE AND COMPACT THE ASPHALT AS PER SPECIFICATIONS.

DETAILED SPECIFICATIONS

1. MATERIALS AND WORKMANSHIP:

ALL MATERIAL AND WORKMANSHIP SHALL COMPLY WITH APPLICABLE SPECIFICATIONS OF ITEMS LISTED IN STANDARD SPECIFICATIONS, CONSTRUCTION AND MATERIALS, NEW YORK STATE D.O.T. DESIGN AND CONSTRUCTION, DATED JANUARY 2, 1981 AND ADDENDA THERETO. THESE SPECIFICATIONS MAY BE MODIFIED AT THE DISCRETION OF THE MAYFIELD TOWN BOARD.

THE NEW PAVEMENT SURFACE MUST BE TAPERED TO MEET ALL EXISTING INTERSECTIONS, DRIVEWAYS AND APPROACHES. THE NEW PAVEMENT MUST MEET ALL SAW CUTS WHERE THE TOWN HIGHWAY DEPARTMENT CHANGES THE CULVERTS IN THE DRIVEWAYS. ANYTHING OVER 50 TONS, A PRICE PER TON WILL BE WORKED OUT BETWEEN THE CONTRACTOR AND THE MAYFIELD TOWN BOARD

2. STREETS TO BE PAVED

(SEE ATTACHMENT "A")

THE TOWN BOARD OF THE TOWN OF MAYFIELD SHALL DESIGNATE THE SPECIFIC STREETS TO BE PAVED AND ADDITIONAL STREETS MAY BE ADDED OR SOME STREETS DELETED, PENDING ON THE OUTCOME OF THE BIDDING PROCESS.

3. TYPE OF ASPHALT

ALL APPLIED ASPHALT SHALL BE NEW YORK STATE D.O.T. SPECIFICATIONS 403.16 TYPE 6 OR RECYCLED TYPE 6, AT THE MAYFIELD TOWN BOARD DISCRETION.

4. TIME FOR COMPLETION: JULY 1 THRU AUGUST 30 2026

THE PAVING WILL NOT BE STARTED BEFORE JULY 1 AND MUST BE COMPLETED BEFORE AUGUST 31, 2026 UNLESS ALTERED BY THE MAYFIELD TOWN BOARD

5. PREVAILING WAGE RATE SCHEDULE:

THE SUCCESSFUL BIDDER MUST COMPLY WITH THE CURRENT WAGE RATE SCHEDULE AND ALL OTHER REUIREMENTS BY THE NEW YORK STATE DEPARTMENT OF LABOR. CERTIFIED PAYROLL AFFIDAVITS ARE TO BE SUBMITTED TO THE TOWN OF MAYFIELD HIGHWAY DEPARTMENT. IT IS EXPECTED THAT WORK PERFORMED UNDER THIS PROPOSAL SHALL BE ACCOMPLISHED DURING THE HOURS OF 6:00 AM AND 5:00 PM MONDAY THROUGH FRIDAY, EXCEPTIONS TO THIS MUST BE APPROVED BY THE MAYFIELD TOWN BOARD.

6. EQUIPMENT:

BITUMINOUS PAVER SHALL BE A SELF – POWERED UNIT HAVING AN ACTIVATEDSCREEN ASSEMBLY. THE SCREEN ASSEMBLY SHALL BE HEATED AS NECESSARY TO PRODUCE A FINISHED SURFACE OF THE REQUIRED EVENESS AND TEXTURE WITHOUT TEARING, SHOVING OR GAUGING THE MIXTURE. ALL BITUMINOUS PAVER SHALL BE EQUIPMENT WITH APPROVED AUTOMATIC TRANSVERSE SLOPE AND LONGITUDINAL SCREEN CONTROL. THE CONTROL SHALL OPERATE FROM SUITABLE FIXED OR MOVING REFERENCES, STEEL WHEEL ROLLERS SHALL BE SELF PROPELLED AND A8 AND 10 TON TANDEM TYPE. EXCEPTIONS TO THESE PROVISIONS MUST BE APPROVED BY THE MAYFIELD TOWN BOARD

7. PREP WORK:

THE TOWN OF MAYFIELD HIGHWAY DEPARTMENT WILL BE RESPONSIBLE FOR SWEEPING OF THE ROADS PRIOR TO THE SUCCESSFUL BIDDERS RESURFACING APPLICATION.

8. BIDDING PROCEDURE:

ALL BIDDERS MUST QUOTE PRICE PER TON OF MATERIAL IN PLACE. THE AWARD FOR THE PAVING CONTRACT WILL BE MADE ON THE BASIS OF THE LOWEST PRICE PER TON IN PLACE. THE TOWN OF MAYFIELD RESERVES THE RIGHT TO REJECT ANY AND ALL BIDS. THE SUCCESSFUL BIDDER WILL BE REQUIRED TO MAKE ANY NECESSARY REPAIRS FOR UP TO A YEAR.

NON- CONCLUSION/WAIVER OF IMMUNITY:

ALL BIDDERS ARE REQUIRED TO SIGN THE ATTACHED NON –
CONCLUSION BIDDING CERTIFICATE AND WAIVER OF IMMUNITY
CLAUSE.

NON-CONCLUSION BIDDING CERTIFICATE

OTETA COMPLIANCE

The 1991 Omnibus Transportation Employee Testing Act. (OTETA), instituted rules that mandate alcohol and drug testing for employees in positions requiring a commercial driver's license, (CDL), Fulton county adopted its own policy consistent with OTETA, effective January 1 1996.
